There were in total 155 attendees. Voting took place by a show of hands, and the Election Commissioners conducted a count. It was established that Mr. Rafaqat Hussain obtained 87 votes, whereas, Mr. Saqlain Shokat had 68 votes. Mr. Rafaqat Hussain obtained the highest number of votes for this position and as such, he was appointed as the Chairman of PKL.
